

## **BUSA NATION REGULATIONS**

Welcome to the BUSA Nation terms and conditions, which apply between you and Brazilian United Corporation - BUC and govern our respective rights and obligations. BUSA Nation aims to reward you, the participant, for your relationship with us.

The terms and conditions listed below constitute the agreement between you and us about your subscription to the BUSA Nation program. Please read these Terms carefully. If you subscribe to BUSA Nation, you are accepting these Terms.

### **1. DEFINITIONS**

You can choose your plan (Joy - United - Beyond), the Subscription is annual and after this period, the plan is automatically renewed for the same period, unless you do not want to renew. In this case, just contact our team.

### **2. ELIGIBILITY AND MEMBERSHIP**

**2.1** The Loyalty Program BUSA Nation is exclusive to individuals, from 10 years old and up. It is individual and non-transferable.

**2.2** To acquire it, the participant just has to choose the association to BUSA Nation in one of the available options, as well as make the monthly payment of the value referring to the desired plan, according to the table in item 4 of this regulation.

**2.4** The participant is responsible for keeping his registration data updated, especially his name, e-mail, phone number and address

**4.1** BUSA-MD materials and uniforms are not included in the United and Beyond discount plans.

**4.2** It is of the Brazilian United Corporation - BUC's total choice to define what comes with the Welcome Kit, as well as the shirts offered and any extra gifts.

**4.3** The Beyond Plan includes an enrollment in the Futsal Winter Travel (practice + League) training, 1 Summer Clinic (of the participant's choice) and 1 Team camp. **4.4** There is no refund after 1 week of purchase of the plan.

## **5. FINAL PROVISIONS**

**5.1** To be able to use and keep on using any BUSA NATION benefit the participant has to have no outstanding monthly payment fees. If the monthly fee is more than 20 days late, the participant account will be deactivated until payment.

**5.2** The participant may request to be excluded from the BUSA Nation program, simply by communicating his or her decision. At the same time, the benefits will be terminated and the participant must return his membership card.

**5.3** The participant, in the act of joining the program, authorizes BUSA Nation to use, for administrative, marketing and advertising purposes, all the data contained in his registration, as well as the consumption information generated, provided that the legal provisions in force are respected, for the development and offer of its own benefits and those of its suppliers or partners, respecting the privacy of the participant and maintaining total confidentiality, not providing third parties with information about the benefits granted.

**5.4** The present regulation may be changed at any time by the Brazilian United Corporation - BUC, at its sole discretion. The participant will be notified of the change in the regulation at least thirty (30) days in advance and the communication will occur exclusively by the contact e-mail provided by the participant. The use of the program by the participant after this period will be considered acceptance of the new terms of the Regulation.
